<sup>- &</sup>lt;u>Active games/physical activity on the property of Poplar Ridge Christian Church:</u> such activities take place regularly during weekly program hours. The games and activities take place in our Student Room and in the gymnasium of our Christian Life Center. We also host games/activities at our softball field and inside the main PRCC building.



- <u>Traveling in Poplar Ridge Christian Church / Third Party Vehicles:</u> many events will require travel from our location to our event destination. All drivers are insured and vehicles are licensed and operational. Wearing a seatbelt is communicated to and expected of all participants. Participants must take personal responsibility to help maintain a safe and lawful environment in the vehicle they ride in.
- <u>Eating meals and foods provided by Poplar Ridge Christian Church:</u> we offer snacks at most Student Ministry programs and meals on Student Ministry trips. Participants must document any food allergies on this form and be conscious of the foods that they ingest.
- <u>Spending the night away from home:</u> there are a few events hosted at Poplar Ridge Christian Church throughout the year that involve spending the night at our church facility or a third party facility. Participants are always housed according to their gender, with an adult in the room or in an adjoining room. Participants are responsible for any damages they inflict upon the facilities. Drugs, Alcohol, weapons, and fireworks are never allowed at any Poplar Ridge Christian Church program or event. Participants who break this rule will be sent home, potentially at the cost of the participant or the participant's legal guardians.
- <u>Lost, destroyed, or stolen belongings:</u> we will make every effort to provide practical instruction and safe storage for any personal belongings that a participant brings to a program, event, or trip. Poplar Ridge Christian Church will not be held responsible for reimbursing lost, destroyed, or stolen items that are not entrusted into our care. Participants who hold on to their own wallets, phones, glasses, cameras, etc. will be responsible for the security of their item/s.
- <u>Medical needs of participants:</u> If medical needs change in the duration of this year, the participant and/or their family must make us aware of the change and update this form. The decision of who holds the medication will be made at the discretion of the participant's legal guardianship and then communicated to our Student Ministry team. There are medications that we cannot administer, and in the case of an emergency we will bring the participant to receive proper medical attention and contact their guardian and/or emergency contact listed on this form.

I hereby release Poplar Ridge Christian Church, including its officers, elders, staff, ministry leaders, and facility in which the activities/events are being conducted from any financial responsibility for injury or illness incurred prior to, during the course of, and after the activities/events.
- 2. To ensure prompt attention in the case of sickness or accident, I hereby authorize the person(s) in charge of said events to incur expense considered necessary for treatment, and I agree to pay for the same if this is in excess of the amount paid by any accident or health insurance policy that may be in effect at the time of the sickness or illness.
- 3. I further acknowledge, understand and agree that in taking part in these activities/events, there is a possibility of physical illness or injury (minimal, serious, or catastrophic) and that I am assuming the risk of such injury by participating.
